2. Approval of the July 9, 2025 Joint Meeting Minutes

The Knoxville TPO staff prepared the Air Quality Determination Report Resolution as required for the adoption of the 26-29 Transportation Improvement Program (TIP). A public notice was posted in local newspapers and the Knoxville & LAMTPO websites for the required 30-day public comment period. A RESOLUTION BY THE LAKEWAY AREA METROPOLITAN TRANSPORTATION ORGANIZATION (LAMTPO) ADOPTING THE FEDERAL FISCAL YEAR (FFY) 2026-2029 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

WHEREAS, in accordance with the Federal requirements of the US Dept. of Transportation, the elements of the transportation planning process are to receive final approval from the Executive Board of the local Metropolitan Transportation Planning Organization, and

WHEREAS, a Transportation Improvement Program (TIP) must be updated at least every four (4) years; and

WHEREAS, no local highway and transit projects are eligible for Federal funds until they are programmed in the Transportation Improvement Program (TIP); and

WHEREAS, this TIP is a subset of the adopted 2050 Metropolitan Transportation Plan; and

WHEREAS, the Federal Fiscal Year (FFY) 2026-2029 TIP has been prepared by the local planning staff and the Technical Advisory Committee subcommittee, with an endorsement from the LAMTPO Technical Advisory Committee;

NOW, THEREFORE BE IT RESOLVED BY THE LAKEWAY AREA METROPOLITAN TRANSPORTATION PLANNING ORGANIZATION (LAMTPO) EXECUTIVE BOARD;

That the requirements of the 23 CFR (Code of Federal Regulations) 450.324 (Transportation Improvement Program, General) are met and this resolution be adopted as an endorsement of the FFY2026-2029 Transportation Improvement Program (TIP).

RESOLUTION 25-010

SUPPORTING THE SAFETY PERFORMANCE MEASURE TARGETS FOR THE STATE OF TENNESSEE

WHEREAS, the Lakeway Area Metropolitan Transportation Planning Organization (LAMTPO) is the organization responsible for planning an efficient transportation system in the Lakeway Region and for the appropriate use of federal transportation funds in the area; and

WHEREAS, in 2012 Congress passed the Moving Ahead for Progress in the 21st Century (MAP-21) and Fixing America's Surface Transportation (FAST) Act that mandate the establishment of a performance and outcome-based program for transportation decision; and

WHEREAS, a national goad has been established to achieve a significant reduction in traffic fatalities and serious injuries on all public roads; and

WHEREAS, the Safety Performance Management Measures regulations support the Highway Safety Improvement Program (HSIP) and require State DOTs and MPOs to set Safety Performance Measure Targets, which apply to all public roads, for five (5) areas; including number of fatalities, rate of serious injuries per 100 VMT, and number of non-motorized fatalities and serious injuries; and

WHEREAS, MPOs have 180 days following the establishment and reporting of the State targets in the HSIP Annual Report to decide regarding whether to support each state's targets or to establish their own; and

WHEREAS, Official reporting of all 5 PM1 targets by TDOT occurred through the Highway Safety Improvement Program (HSIP) in August 2025; and

WHEREAS, the 2022-2026 Safety Performance Measure Targets adopted by the State are shown on the next page, and

WHEREAS, the LAMTPO Technical Advisory Committee (TAC) and Executive Board approved and supported the Tennessee Department of Transportation (TDOT) 2022-2026 PM1 Safety Performance Measure Targets as shown on Attachment A; and

BE IT FURTHER RESOLVED that the LAMTPO Executive Board hereby approves and supports TDOT's 2025 Safety Performance Measure Targets at their scheduled meeting on November 12, 2025.

2025 Safety Targets Verification

Please review the 2022-2026 PM1 Safety Performance targets and justifications TDOT submitted to the Federal Highway Administration. The targets have been reviewed and approved by TDOT executive leaders. Official reporting of all 5 safety targets by TDOT occurred through the Highway Safety Improvement Program in August 2025. THSO submitted the 2023 Triennial Highway Safety Plan, which included the targets for the three common safety performance measures (number of fatalities, fatality rate, and number of serious injuries).

For each measure, MPOs can choose to support the statewide PM1 target or establish their own numerical target. Those decisions must be made within 180 days after State targets have been officially reported (no later than February 27, 2026). MPOs must make a determination for Number of Fatalities, Fatality Rate, Number of Serious Injuries, Serious Injury Rate, and Number of Non-Motorized Fatalities and Serious Injuries

Provided in the table below are the 2020-2024 Baseline Performance Cycle data TDOT used in target setting:

^{*}The Federal Highway Administration (FHWA) is responsible for calculating baselines. This table identifies baselines TDOT anticipates will be published by FHWA at their State Performance Dashboard and Reports webpage.

Any adjustments to the targets or annual baseline data requested by FHWA will be communicated to the MPOs. Since baseline data is still preliminary at the time of reporting to FHWA, TDOT does not anticipate these will be the actual baselines used to assess the state's performance in December 2027.

Calendar Year 2026 Targets *

Number of Fatalities 1253.9 Describe the basis for established target, including how it supports SHSP goals.

The target was determined by averaging the number of fatalities in 2022, 2023, 2024 and projected fatalities for 2025 and 2026. To project fatalities for 2025 and 2026, the average percent change of 1.26% in serious injuries from the baseline performance period (2020-2024) was applied as the annual percent change from 2024 to 2025 and 2025 to 2026. The target was approved by TDOT leadership.

Number of Serious Injuries 5924.8 Describe the basis for established target, including how it supports SHSP goals.

The target was determined by averaging the number of serious injuries in 2022, 2023, 2024 and projected serious injuries for 2025 and 2026. To project serious injuries for 2025 and 2026, the average percent change of 1.06% in serious injuries from the baseline performance period (2020-2024) was applied as the annual percent change from 2024 to 2025 and 2025 to 2026. The target was approved by TDOT leadership.

Fatality Rate 1.554 Describe the basis for established target, including how it supports SHSP goals.

The target was determined by calculating and averaging the fatality rate per 100 million VMT for 2022, 2023, 2024, and 2025 and 2026 with projected fatalities. For the years 2025 and 2026, the 2024 VMT estimate was applied with a 0% increase in VMT. The same projected numbers used to calculate the Number of Fatalities target for the 2022-2026 performance cycle were used to calculate the individual rates for those years. The target was approved by TDOT leadership.

The target was determined by averaging the number of serious injuries in 2022, 2023, 2024 and projected serious injuries for 2025 and 2026. To project serious injuries for 2025 and 2026, the average percent change of 1.06% in serious injuries from the baseline performance period (2020-2024) was applied as the annual percent change from 2024 to 2025 and 2025 to 2026. The target was approved by TDOT leadership.



2025 Safety Targets Verification

Serious Injury Rate 7.349 Describe the basis for established target, including how it supports SHSP goals.

The target was determined by calculating and averaging the serious injuries rate per 100 million VMT for 2022, 2023, 2024, and 2025 and 2026 with projected serious injuries. For the years 2025 and 2026, the 2024 VMT estimate was applied with a 0% increase in VMT. The projected numbers used to calculate the Number of Serious Injuries target for the 2022-2026 performance cycle were used to calculate the individual rates for those years. The target was approved by TDOT leadership.

Total Number of Non-Motorized

Fatalities and Serious Injuries

Describe the basis for established target, including how it supports SHSP goals.

The target was determined by averaging the number of non-motorized serious injuries and fatalities in 2022, 2023, 2024, and projected fatalities for 2025 and 2026. To project number of non-motorized fatalities and serious injuries in 2025 and 2026, the average percent change of 4.59% in serious injuries from the baseline performance period (2020-2024) was applied as the annual percent change from 2024 to 2025 and 2025 to 2026. The target was approved by TDOT leadership.
