I. START OF MEETING/ ROLL CALL

IV. Discussion of the Transit Center Feasibility Study

Online survey went live on June 12, 2023. There were 67 responses after the 1st week. Several people had viewed the survey but not as many had taken the survey. WSP is working on a location analysis currently. Staff will keep LAMTPO members posted as this project moves forward. There will be a meeting on October 5, 2023, and may be one in September, but trying to get confirmation from the consultant. Staff will keep the TAC posted on this situation. No action is needed at this time.

V. Status Update of the 11E Corridor Study in Jefferson City

CDM Smith will be doing a presentation to the Jefferson City City Council on August 15, 2023. No action is needed at this time.

VI. Status Update of the SR160 Corridor Study in Morristown

CDM Smith Associates gave an updated presentation on the study. Melody Butler and Stephanie Hargrove of CDM Smith gave a financial cost overview of the SR160 Corridor study. There was some discussions on street lighting, traffic counts at each intersection, etc. The next presentation may be on August 25th at the Executive Board meeting, or possibly the following week. Staff will keep the TAC updated as this progresses.

VII. Information/ Updates from FHWA/ FTA/ TDOT

No other info was given.

VIII. Other Business

Resolution of support for SR160 project priority rankings as requested by the City of Morristown. Staff recommends approval as submitted. A motion was made by Bill Brittain, seconded by Mike Patterson, to approve the resolution and to forward to the Executive Board for approval. The motion was approved unanimously.
