## II. Approval of the June 21, 2023 minutes

# VI. Status Update of the SR160 Corridor Study in Morristown

CDM Smith Associates gave public presentation on July 6 2023. This was the 2<sup>nd</sup> public presentation.

# VII. LAMTPO UA and MPA Boundary

The US Census Bureau 2020 UA population for LAMTPO is 66,539. The proposed MPA boundary population is 97,131.

Staff gave a couple different options, it was noted that Bean Station will be a member in either option, based on the minimum 2,000 population threshold as stated within the ByLaws/ Prospectus of LAMTPO, or Grainger County could be a member of LAMTPO, depending on which MPA boundary option is chosen. It was decided to hold off for now and come back at a later date.

Staff will do a MPO 101 on July  $20^{\text{th}}$  in Bean Station for the mayors of Grainger County, Bean Station, and Hawkins County.
