III. Discussion of the Proposed Weigels on SR341/ Roy Messer Hwy in White Pine

A proposal for a new Weigels convenience store, as well as several other commercial developments to occur along SR341 in White Pine. There was concern for having too many driveway access points onto a state route, and with a new private high school coming in, and with the new SR66 anticipating to open up in Spring 2020, there is concern about traffic safety and flow within this area. TDOT had given some various proposals, and a motion by Bob Hardy, seconded by Michelle Christian, was to recommend to the White Pine Planning Commission either Sketch F, which had Weigels and 3 other parcels having connecting parking lots and shared driveways; or Option 2 which had an access road behind Weigels

and connecting to the other outparcels. With no other discussion the motion was approved unanimously.

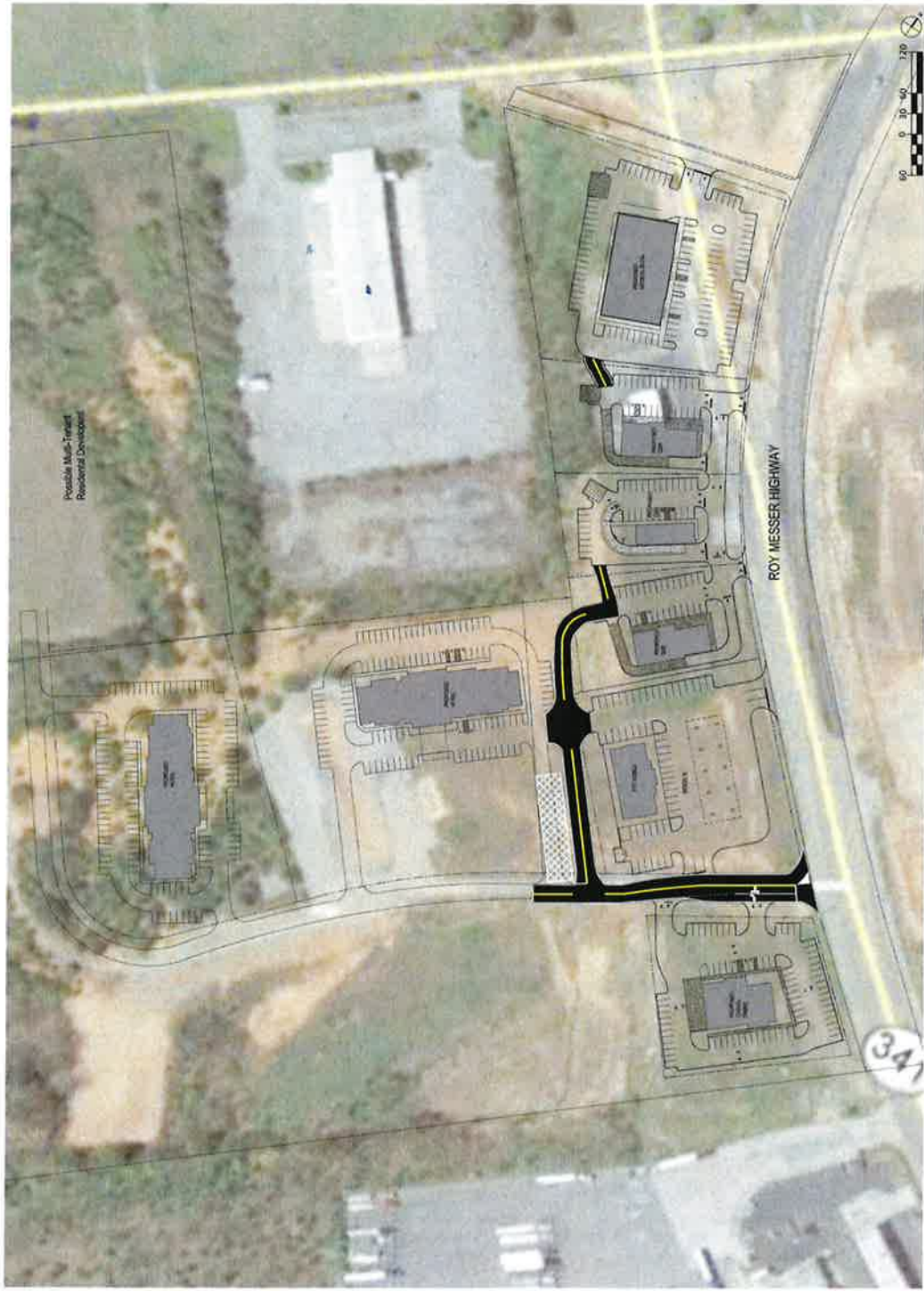
